don Simpkinson said. Smoldering fires produce bigger particles than most fires, and ionization alarms can only detect smaller particles. Photoelectric alarms can detect a greater range of particles, and can tell when there's enough smoke to be a serious fire. They are already the most common type of alarm in China and Europe, and four U.S. states have ordinances that require them.

2. Install carbon-monoxide alarms. The toxic compound carbon monoxide, 1, 2011, will mandate carbon-monoxide alarms in all houses sold or rented.

Skids on slippery steps can be prevented by installing decorative rubber mats (nailed down), as well as sandpapery, nonskid strips.

areas, garages and around pools and hot tubs. Ground fault interruption outlets automatically disconnect when they detect an imbalance in the electric current — sometimes caused by a person touching the live side of the circuit and water or pipes.

- **4.** Install handrails and nonskid strips on stairs. Falling-related accidents are a leading cause of injury among the elderly. Even with no grandparents in the house, homeowners are liable if a guest or ten-
- **5.** Have a licensed contractor bolt your house to the foundation and strap water heaters to the wall. This will reduce damage in the event of an earthquake. In the past, many

contractors secured water heaters with only one strap, but Palo Alto Office of Emergency Services Coordinator Suzan Minshall now recommends two straps. One strap should be two feet from the floor, and one strap should be two feet from the top of the water heater.

6. Bolt bookshelves, entertainment centers and other tall and heavy furniture to the wall. Deliberately consider where to hang objects and how they're hung — nothing should be over the bed or couch. Consider using museum wax to affix heavy items to bookshelves.

- **7.** Use flexible plastic connectors for all gas-related appliances, such as water heaters, dryers and stoves. In the event of an earthquake, rigid metal connectors can snap and leak gas, Minshall said. If your home has gas piping under its foundation, hire a professional contractor to evaluate the pipe for corrosion and bypass if needed. If you ever smell gas, call 911 from outside your home.
- **8.** Prepare emergency kits for your home and car. Include items such as drinking water, food, cash, first-aid supplies, flashlights and batteries, a battery-operated radio, blankets, important documents such as insurance-policy and bank-account information. Minshall also recommends that people store a pair of shoes and a flashlight in a bag near their bed to allow a safe exit if there's broken glass and no power. Keep in mind any special needs of household members, particularly young children and the elderly. Store camping supplies such as sleeping bags and warm clothes in an easily accessible location, such as a shed or garage.
- 9. Replace external window guards that aren't quick release from the inside. Non-quick-release window guards can trap residents inside a burning home.
- 10. Teach friends and family to 'drop, cover and hold on" in the event of an earthquake. Designate a

safe location outside the home as an emergency gathering place.

For those interested in learning more, there are two local opportunities in the next month for emergency-preparedness education. From plain to fancy

Decorative boxes are useful for storage and display by Kit Davey

ant to keep clutter at bay and add personality to your home at the same time? Create your own decorative containers for storage and display.

You don't need to spend an arm and a leg buying new containers: Just recycle ones you already own. Almost any container can be converted into a useful and attractive storage device: sturdy gift boxes, cardboard file boxes, matchboxes, O-tip boxes, hat boxes, recipe files, old jewelry boxes, cigar boxes, photo boxes, shoe boxes, spice jars, tea tins, fruit crates, etc.

If it has a lid and can hold some-- re-use it!

You can use almost anything in your junk drawer to decorate

vour container: shells, ribbon, lace, old stamps, photos, pictures from magazines, postcards, broken jewelry, old maps, wallpaper scraps, fabric, twigs,

moss, keys, foreign coins, buttons, potpourri, pressed leaves. Go on a treasure hunt for odds and ends that you can apply to your contain-

What can you store in your new box? Just about anything: jewelry, office supplies, vitamin pills, paperwork, TV remotes, art supplies, make-up or stationery. You can also give your boxes as gifts.

Here are a few projects you

might enjoy:

- Do you have cardboard file boxes stacked up in your den? Make them much more attractive by decoupaging images from magazines onto the sides you can see. I cut out a snake and a dragonfly from a Nature Company shopping bag and applied it to a storage box. Leftover wallpaper or wrapping paper can add interest to any boring cardboard box.

 • Matchboxes make perfect
- containers for straight pins or earring backs. Cut out a small piece of colorful paper (advertisements for Persian carpets, cut from interior-design magazines, are perfect for this) and glue it onto the box, avoiding the striking strip. Use a glue gun to add an old Chinese coin, a medallion or a button to the top of the box. Five or six of these homemade boxes sitting on a small tray look great. You can even keep the matches in them!
- Fruit crates with attractive labels can be used "as is" to hold

a collection of flower pots out on your deck or patio. Or, paint a few crates to match your room's decor and store your record albums in them. Strong crates can be used to house kids' toys

- Give a small, sturdy gift box a Victorian look. Collect a handful of straight twigs, a few bits of moss and several small acorns on your next country walk. Look through your family photos for a sepia-toned image, or use an antique store purchase. If you are afraid of damaging the image, take it to your local copy shop and have a color copy made. Glue the photo to the box lid and create a frame around the image with your twigs. Glue the twigs and a few bits of moss to the lid as well. Add a pair of acorns to one corner. Use your box to store pens, hair pins or a postcard collection.
- ** Dress up a shoe box with ribbon and a few buttons. Spray paint the box with gold paint. Glue a length of ribbon around the box lid

 burgundy or forest green work well. Glue buttons onto the ribbon every inch or so. Store computer disks, handkerchiefs, an old set of

silverware or receipts in your box. • Recycle fabric scraps and make yourself a padded box. Select a strong, lidded box. Cut out a piece of quilt batting and glue to the box lid (you can also use pillow stuffing). Cut out a square of fabric, four to six inches larger than the box lid. Wrap the lid, Christmaspresent style, using a glue gun to attach the fabric to the inside of lid. Glue sections of the same or complementary fabric to the panels on the bottom of the box. Stash old check registers, sewing supplies or travel soaps.
